

**ST. LOUIS FAMILY CHURCH
LIABILITY RELEASE STATEMENT / PARENT PERMISSION
FOR SKATE PARK PARTICIPANTS**



I hereby give my permission for _____, my child, to attend the St. Louis Family Church Skate Park ("Skate Park").

I acknowledge that skateboarding, in-line roller blading, and BMX bicycling at a skate park entails known and unanticipated risks that could result in physical or emotional injury, paralysis, death, or damage to me, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity.

I understand that St. Louis Family Church, its officers, directors, employees, sponsors, volunteers, agents and assigns (hereinafter collectively referred to as the "Releasees") shall not be liable for any damages on account of injury to the person or property or resulting in the death of my child, which might result not only from my child's own actions, inactions, or negligence, but also the actions, inactions or negligence of the Releasees, or the condition of the vehicles, premises, facilities, or of any equipment used while my child participates at the Skate Park.

I assume full responsibility for any injuries or damages which may occur to my child during his/her participation at the Skate Park. In consideration of my child being allowed to participate at the Skate Park, I do hereby fully and forever covenant not to sue, waive any and all causes of action against, release, waive, and discharge the Releasees from all liability to the undersigned, my child, our personal representatives, assigns, heirs, and next of kin for any and all claims, demands, damages, rights of action or causes of action, present or future, whether the same be known, anticipated or unanticipated, which I or my child may have or accrue as a result of my child's participation at the Skate Park whether caused by my child's own actions, inactions or negligence, or the actions, inactions, or negligence of the Releasees, or the condition of the vehicles, premises, facilities, or of any equipment used at the Skate Park.

I understand St. Louis Family Church carries no medical insurance on participants. I have and expressly accept the responsibility of providing health and accident insurance for my child in the event of any illness or injury experienced at the Skate Park.

I agree that this agreement shall be governed by and construed in accordance with the laws of Missouri without regard to conflict of laws provisions. All disputes arising from the Skate Park, this agreement, or its terms shall be brought in either the United States District Court for the Eastern District of Missouri or the St. Louis County Circuit Court.

If any provision of this agreement or the application thereof is held invalid or unenforceable, the other provisions of this agreement will not be affected thereby.

I have carefully read this agreement and understand its contents. I am aware this is a waiver and a release of liability, including any liability based upon Releasee's own negligence, and I sign it voluntarily.

YOUTH AGREEMENT (UNDER 18)

As a participant at the Skate Park, I will fully cooperate with the Skate Park leaders and chaperones. I understand that if I violate this agreement, my parents will be contacted and arrangements will be made to send me home immediately.
