

**St. Louis Family Church Special Event Adult and Minor Waiver,
Liability Release and Publicity Release**

Event Name and Location: High School Youth Retreat at Lake Williamson

I understand and agree on behalf of myself and my minor child, if applicable (adult and child participants are referred to as "Participant"), that this Event exposes Participant to certain risks, including the risk of illness, personal injury, or death. Participant chooses to participate in this Event with a clear understanding and acknowledgement of these risks. This Event includes, but is not limited to, St. Louis Family Church ("SLFC") fellowship activities, on campus activities, travel, off campus activities, physical exercise, recreation and entertainment. Participant has and hereby expressly accepts the responsibility of providing Participant's own health and accident insurance in the event of any illness or injury experienced during this Event and/or traveling to or from this Event.

Participant understands and expressly agrees that SLFC, its officers, directors, employees, sponsors, agents, assignees, shareholders, members, principals and volunteers (collectively referred to as "Released Parties") shall not be liable for any damages for injury to Participant's property or injury to Participant or any circumstance resulting in the death of the Participant, which might result not only from Participant's own actions, inactions, or negligence, but also from the actions, inactions, or negligence of the Released Parties, or the condition of the premises, facilities, vehicles or of any equipment used while the Participant participates in this Event.

Participant assumes full responsibility for any injuries, damages or death which may occur to Participant during Participant's participation in this Event. In consideration of being allowed to participate in this Event, Participant does hereby fully and forever release, waive, discharge and covenant not to sue the Released Parties from all liability, including without limitation, injury to Participant's property, injury to Participant or death of Participant, to Participant, Participant's personal representatives, assigns, heirs, and next of kin for any and all claims, demands, damages, rights of action or causes of action, present or future, whether the same be known, anticipated or unanticipated, which Participant may have or accrue as a result of Participant's participation in this Event whether caused by Participant's own actions, inactions, or negligence, or the actions, inactions, or negligence of the Released Parties, or the condition of the premises, facilities, vehicles or of any equipment used during this Event. As a Participant in this Event, Participant confirms that Participant is not participating as a duly elected representative nor as an employee of SLFC or Service International, Inc.

Participant hereby agrees and consents that SLFC may use without payment or other consideration Participant's picture, silhouette, likeness and voice, name, performance, interview and any transcripts and/or portions of any of the foregoing (collectively referred to as "Participant's Likeness") in any medium in connection with this Event or any other SLFC projects in any respect. SLFC may edit Participant's Likeness as deemed appropriate by SLFC. Participant hereby agrees and consents that SLFC, may use all or part of

Participant's Likeness for use in SLFC projects including by way of example and not by limitation, any activity sponsored by SLFC in any respect.

The rights granted to SLFC herein are perpetual, worldwide, and Participant understands SLFC will incur substantial expense in reliance on this agreement. SLFC shall have all right, title and interest in any and all results and proceeds, if any, from said use of Participant's Likeness. SLFC is not obliged to make use of Participant's Likeness or exercise any of the rights granted to SLFC by this agreement. Participant hereby releases SLFC and the Released Parties from any and all claims, including without limitation, libel, slander, or invasion of privacy or publicity rights with regard to Participant's Likeness or their use by SLFC.

Participant agrees that this agreement shall be governed by and construed in accordance with the laws of Missouri without regard to conflict of laws provisions. All disputes arising from this Event, the Participant's Likeness or SLFC projects, this agreement or its terms shall be brought in either the United States District Court for the Eastern District of Missouri or St. Louis County Circuit Court. If any provision of this agreement or the application thereof is held invalid or unenforceable, the other provisions of this agreement will not be affected thereby.

I have carefully read this agreement and understand its contents. I am aware this is a waiver and a release of liability and publicity, including any liability based upon the Released Parties own negligence, and I sign it voluntarily.
